Only purebred Salukis that are one year of age or older on the day of the trial may be entered. All entries shall be individually registered with the American Kennel Club, the Federation Cynologique Internationale, an ASFA recognized foreign or ASFA board approved registry, or possess a critique case number (CRN) from the Society for the Perpetuation of the Desert-Bred Saluki (SPDBS).

Incomplete, unsigned, conditional, or late entries will NOT be accepted.

Stakes Offered:

Open: Any eligible Saluki that has met the certification requirements at the time of closing, excluding ASFA Field Champion Salukis of record.

Field Champion: Any ASFA Field Champion Saluki.

Veteran Stake: Any eligible Saluki whose age exceeds six years, who has met certification requirements at the time of closing.

Single – Any eligible Saluki including those disqualified to run in other stakes. Hound will run alone. No ASFA points are awarded. Ribbons are awarded. Does not complete in Best of Breed.

Limited to 15 hounds.

Breeder Stake: Any two Salukis bred by the same person and designated at the time of entry.

Kennel Stake: Any two Salukis owned and kenneled by the same person and designated at the time of entry.

Conditions of entry:

All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds may be entered in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

A battery powered continuous-loop machine will be used. With highly visible plastic strips for the lure. Back-up equipment will be available. A \$20.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to SCOA any hound(s)/other person(s) will be asked to leave the trial site.

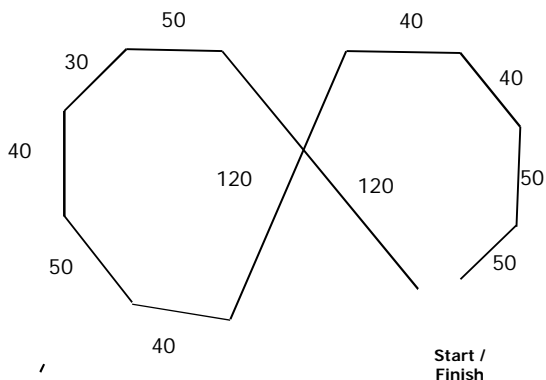
Owners must keep their hounds under control and clean up after them. A \$10 fine will be assessed for any hound loose on the field not competing in the course in progress.

The altitude is 6,350'. Please bring your own shade and water. Overnight self-contained camping is allowed by the field. No fires on the field and no smoking on the field. Port-a-potti on site. Please include a phone number on your entries in case we need to reach you.
